- 01 Arbitrators are listed in alphabetical order by the pinyin of their surnames.
- 02 If a party selects an arbitrator residing in a different city, they shall bear the travel expenses incurred by the arbitrator when handling the case.
- 03 Arbitrators marked with an “*” do not accept selection by the parties.
- 04 If a party selects an arbitrator with a same name, they should specify the arbitrator along with the number in the “()”.
- 05 The list of arbitrators published on the official website, official WeChat account, and other official media of the SAC has the same effect as this panel.
